Enrichment Agreement

Persons withdrawing from a class or activity more than 5 business days prior to the start of a class or activity can receive a refund minus a \$5 processing fee OR transfer to a different class or activity in the same brochure, or receive a credit for a similar program by June 30.

MANDATORY & ENFORCEABLE CODES OF CONDUCT FOR PARTICIPANTS, PARENTS AND SUPPORTERS

<u>Waiver</u>: I hereby represent that I/my child is in good health and may participate and compete in rigorous physical activity and authorize the Independent School District 192 to secure any medical emergency treatment deemed necessary and waive and release ISD 192 and employees from any liability for injuries or damages sustained by me/my student at the designated activity.

<u>Parent / Guardian Medical Emergency Authorization -</u> In the event of a medical emergency while my child is participating in the program, I authorize the adult in charge of the program or designee to release the medical information provided by me to the healthcare provider, and to arrange for treatment in an emergency. I understand that Community Education officials will use the contact information provided to try to contact me in the event of such an emergency. I agree to be financially

responsible for the costs of any such medical procedures or treatment. I understand that Community Education/ISD 192 does not provide medical/health insurance for me/ my student.

<u>Expectations</u>- I understand that I/my student will follow instructions given by the adult in charge of the program and will comply with all rules for student conduct for the Community Education program.

Negative attitudes, behavior, and disrespect to instructors/coaches or peers will not be tolerated. If this occurs, disciplinary action will be taken, including possible dismissal from the program.

Informed Consent—By its nature, participation in this program's activities includes risk of injury and the transmission of infectious diseases such as Human immunodeficiency virus (HIV), Herpes, Hepatitis B and others. Although serious injuries are not common and the risk of HIV transmission is almost nonexistent in supervised Community Education programs, it is impossible to eliminate all risk.
